Applicants must reside within the Braymer C4 School District

Hours of Operation 5:30 pm to 6:00 am Monday Afternoon thru Friday Morning. Weekend times will be from 5:30 pm Friday Evening thru 6:00 am Monday Morning. Priority will be given to Braymer High School students during school hours as well as practice and game times. Wellness Center will be close for all home Football games.

Code of Conduct Applicant will agree to abide by all policies and procedures of the Braymer School District Wellness Center and understand that failure to act in accordance with these rules may result in suspension or complete loss of access to the Braymer School District Wellness Center. Applicant further acknowledges that they have received a copy of all the policies and procedures.

Property Loss Applicant understands that the Braymer C4 School District is not responsible for personal property lost, damaged or stolen while using district facilities.

Criminal History Applicant acknowledges that it is the policy of the Braymer C4 School District to deny membership to any individual accused or convicted of any crime involving sexual abuse or, is or has been a registered sex offender. The Braymer C4 School District will periodically check its membership records for criminal history. It is the applicants' responsibility to communicate within 48 hours to the Braymer C4 School District should a violation occur to ensure the safety of everyone using the Wellness Center. Failure to communicate a violation within the designated timeframe could result in a permanent suspension.

Proper Attire and Hygiene Wearing exercise clothing such as shorts, sweats, tank-tops, and athletic shoes will help to make your workout more enjoyable. Wearing blue jeans or other clothing that have external metal parts or rigid seaming is prohibited. These items can cause damage to the upholstery on the equipment. Shirts and **clean shoes** must be worn at all times in the facility. *Equipment should be wiped clean after use.*

Food and Drink Food is prohibited. Water only. No sports drink please.

Tobacco & Alcohol Free Area Braymer C4 School District helps promote healthy lifestyles; use of tobacco products (cigarettes, e-cigarettes, cigars, pipe, chewing tobacco, or snuff) and alcohol are not permitted on school grounds.

Damages Applicant understands that they may be responsible for the cost of repair/replacement of any damages caused by the applicant.

Age Requirements During non-school hours, no one under the age of 18 will be allowed in Wellness Center unless accompanied by a parent. The Weight equipment and or machines are not toys and/or jungle gyms and should not be used by an elementary age child. If you bring your children with you, please monitor them accordingly.

Member Assumption of Risk and Release The Applicant understands and accepts the risk of injury from using facility equipment is significant, including the potential for permanent injury and/or death, and the applicant knowingly and freely assume all such risks, both known and unknown. Applicant acknowledges that this is an unsupervised facility and they assume all risks associated with using exercise equipment and exercising alone. Applicant hereby release, indemnify, and hold harmless the Braymer C4 School District.

Safety Notices

- The facility is under 24-hour recorded video surveillance and your member access usage is logged.
- Guests are not permitted at any time. If this policy is violated, at our sole discretion, your access to the facility may be temporarily suspended and/or permanently suspended.
- Applicant must not allow anyone else to use their access key and applicant must alert the school district immediately if it is lost or stolen. Violating this policy carries the same consequences as violating the guest policy. Allowances may be made for visiting relatives. Please contact the school in advance for permission.
- Horseplay, vulgar language, abuse of the equipment, working out while intoxicated, or other inappropriate behavior will not be tolerated and may result in temporary suspension and/or permanent suspension.
- No one is allowed beyond the Wellness Center area. The locker rooms are not part of the Wellness Cent area and are not to be accessed at any time. If this policy is violated, at our sole discretion, access to the facility may be suspended and/or permanently suspended.

Maintenance of Facilities The facility may be temporarily closed for a period of up to two weeks each year for maintenance purposes.

Access Card Initial access key will be *free* of charge, 1 per family/additional cards may be purchased for \$5. Additional or replacement keys will cost \$5.00 each. All access keys will be deactivated annually; reactivation will take place upon signing a new agreement form effective July 1st.
